

# SCHOOL SAFETY CERTIFICATION COURSE

These Classes are designed to train and evaluate educators and employees to carry defensive handguns on school campus. Classes provide the Texas D.P.S. approved training for school districts. Classes also include a custom training plan based on your educational needs and environment. During the state-mandated two days of instruction we place students into real-world scenarios and testing.

The cost for this 16 Hour course is **\$300.00 per person** (you provide a handgun and ammo), and the class size is strictly limited to a maximum of 6 by state regulation.

There are no other fees. School employees who complete the course will receive a DPS Certificate of Completion after the Class **no waiting**.

## **YOU MUST HAVE A CURRENT TEXAS LTC LICENSE TO TAKE THIS COURSE**

### **PRE-EXAM QUALIFICATION DEMONSTRATION**

- Pre-Qualification Range Test 50 rounds live fire - 90% (225) score on LTC qualification
- Pre-Qualification Written Test- based on existing LTC laws and regulations (90% required)

The Pre-Range Test is the same distance and shots fired as the LTC Range Qualification.

### **Exceptions to LTC Range Test:**

- To score a minimum of 225 and a Handgun caliber of .38 or above.
- Students are not allowed to "make up" rounds that are not fired within the allotted time, including malfunctions (Jams or a round did not fire).
- School Safety Certified Instructor(s) will conduct the pre-exam LTC course proficiency demonstration and scoring of targets **ONLY**.

### **RANGE SAFETY:**

- Eye protection
- Over the ear hearing protection--muff type--to cover the ear and the area behind the ear
- Head cover-cap or hat that will cover the head and the area toward the face (such as a baseball cap)
- Footwear must cover the entire foot
- No shorts will be allowed on the pistol range for safety purposes
- Wear a shirt with a collar to the range
- **UNLOADED HANDGUN** and Ammunition are to be placed in a case or carrying bag (Concealed)
- **NO MANIPULATION OR HANDLING OF HANDGUNS IN THE PARKING LOTS!**
- **NO HANDGUNS ARE PERMITTED IN THE CLASSROOM** unless authorized by the instructor

**IF YOU DO NOT PASS THE PRE-QUALIFICATIONS YOU CANNOT TAKE THE COURSE AND WILL HAVE TO REAPPLY**

## COURSE OBJECTIVES

- Protection of Students
- Interaction of license holders with first responders
- Tactics for denying an intruder entry into a classroom or school facility
- Methods for increasing a license holder's accuracy with a handgun while under duress
- Shooting under duress 120 round live-fire proficiency using hostage targets
- Final written exam (90% required)
